Subject: Intimation under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') - Update on Joint Venture Agreement between Syrma SGS Technology Limited ("Company") and Shinhyup Electronics Co. Ltd- Approval of Government of Andhra Pradesh.

Dear Sir/Madam,

With reference to the captioned subject, we would like to inform you that the Company has entered into a Joint Venture Agreement with Shinhyup Electronics Co. Limited, South Korea ("Shinhyup Electronics") on July 15, 2025 for manufacturing of multi-layer Printed Circuit Board (PCB) and Copper Clad Laminate (CCL) for automobile electronic equipment, home electronic appliances, IT and medical services in India.

In this regard, we wish to update that the Government of Andhra Pradesh has vide its order dated September 9, 2025, has approved the proposals of the Company as detailed below:

- Allotment of 26.70 acres of land at Menakuru Village, Naidupeta, Andhra Pradesh, to be made available by APIIC for establishing a Manufacturing and R&D facility for single, multilayer, HDI, and Flex printed circuit boards, a Copper Clad Laminate manufacturing facility and an Electronics Manufacturing Services facility.
- Incentive packages under Andhra Pradesh Electronics Components Manufacturing Policy (4.0), 2025-30, subject to the approval of the same application from Govt. of India and the AP Electronics Manufacturing Policy 4.0 (2024- 29)
- The above proposal would involve investment of around INR 1595 crores for all the projects together.
